II In as much as at this same time a ruthless trimming of trees that had been landmarks on the Ridge was carried on with no thought of preserving the life, beauty and symmetry of said trees; Resolved that hereafter all tree-trimming shall be confined to the property of the person who trims the trees, and that the tree warden be requested to grant no permission for any trimming of the town trees on the Ridge except with the agreed consent of the President of the Ridge Association.
