Rustic Ridge Association Board Meeting Minutes Wednesday, July 8, 2020, 6:00 P.M. EST Teleconference

Attendance – Margie Conner, Martha Schoonover, Barbara Walker, Doug Denise, Lisa White, Bill Young, Leesa Campbell, Linda Glover, Lindsey Lack, Bob Ziegenhagen, Doug Southard, Jean Bubriski. Guests: Carol Ziegenhagen and Lucy and Phil Livingston

Personal Update – Board Members gave updates on their status and plans as we isolate ourselves due to the epidemic.

Minutes - Minutes from the April 29, 2020 Board Meeting were approved.

Financial Reserve Status – Doug Denise, Treasurer, summarized the Rustic Ridge Association's current financial status and presented initial 2020-2021 budget numbers for review and discussion. The Association's bank balance is currently \$32,847. Highlights:

- Dues have been paid for 52 cottages (45 Active Members 5 paid for 2 cottages, 1 paid for 3 cottages). Total received = \$7,350.
- Dues have been received for 26 Associate Members. Total received = \$1,040.
- Contributions to date are \$1610.
- The Ridge has now been granted federal tax-exempt status. It took a great deal of effort to attain this status and we do not intend to repeat the process at the moment for Massachusetts tax exempt status since the return would be minimal.
- The Board received updated committee expense projections and Doug will liaise further before submitting a revised budget for the Annual meeting.

Road Report - Lucy and Phil Livingston reviewed the road work accomplished since the April 2020 meeting as well as work planned for the balance of the year. Highlights:

- Work is planned on Willows, both the upper section (repave) and lower (pothole).
- Culverts will be cleared out on Oak Terrace and East lane, with the damaged roadway repaired on Oak Terrace.
- Saplings and brush adjacent to the roads were cut back and the roads themselves were swept.
- The root upheaval problem on West Lane continues to vex us. We cannot simply add macadam to smooth out the area as this would raise the road surface too much, creating a flooding risk to adjacent homes. Cutting the roots down to the macadam level might weaken the huge trees towering over the roads and

cottages. The Board asked Lucy and Phil to consult with a tree expert for better perspective on this tree safety aspect.

• The Board expressed frustration that heavy trucks continue to drive on and damage our roads, despite requests to refrain. Options for improving the situation were discussed.

The Board agreed that we do not need the position of Assistant Clerk at this time but that we should possibly strengthen ties to the Social and Road committees.

The Board approved the proposed slate and thanked the other members of the nominating committee (Margie Conner, Jean Bubriski and Leesa Campbell) as well as retiring Board members and Charlotte Martin, retired nominating committee member.

Annual Meeting Planning - As an emergency adaption to the Covid-19 crisis, the Board agreed to have a virtual as opposed to physical annual meeting in August 2020.

The Ridge Clerk will send Zoom invitations and all meeting materials to Association members in advance of the meeting. He will also assist other Board members in helping our more digitally challenged Association members hook up to the meeting. The Agenda will be similar to last years.

The meeting adjourned at 7:44 PM Eastern Time.

- 5. Federal Tax Exempt Status Update. We received a determination letter from the IRS, dated June 11, 2020, stating that our tax exempt status as a 501(c)(4) organization has been reinstated. A copy of that letter and the application (Form 1024-A) submitted to the IRS is available to Board members upon request.
- 6. Our Federal Tax Return Form 990-N for FY18-19 was filed June 24, 2020. I called the IRS that same day to find out if un-filed returns for FY15-16, FY16-17 and FY17-18 also needed to be filed. The IRS representative indicated it is NOT required to do so. Also, she said while it is NOT possible to file prior year returns electronically, it is possible to engage a 3rd party to do so. Unless I learn differently or am instructed to do so, I have no plans to file these un-filed returns.
- 7. Financial Records Online. As a stop-gap measure to protect key Rustic Ridge Association financial records, these records are now online in my personal Dropbox account.
