## Re: East Northfield Water Company, D.P.U. 19-57

Dear Ms. Luksha:

Pursuant to G.L. c. 164, § 94, and G.L. c. 165, § 2 and C.M.R. §§ 5.00 <u>et seq.</u>, East Northfield Water Company (the "Company") seeks approval from the Department of Public Utilities of changes in its schedule of Rates and Rules and Regulations listed in the Company's Transmittal Letter. These proposed rate changes (including Miscellaneous Charges) would result in a two step annual increase in revenue of \$85.911 (rate year 1) and \$120,911 (rate year 2).

In support of the Company's request, we are submitting the testimony of John E. Alden, Jr. and David M. Fox with supporting exhibits. The Company has also submitted a Petition for Approval and its proposed M.D.P.U. No. 13 for effect June 1, 2019 which cancels and supersedes M.D.P.U. No. 12.

The effect of the changes to the Company's rates on operating revenues and on the customers in the Company's single rate classification is shown on the following table:
